



## SEASON 2024 MEMBERSHIP FEES – CATEGORY FOUR (INDIVIDUAL MEMBERS)

For Netball Queensland's 2024 Membership period (1 January – 31 December), the following membership products are available (prices quoted include GST):

- 2024 Playing Membership - **\$112.00**
- 2024 NetSetGO! (Pack Eligible) - **\$105.00**
- 2024 10 Week Season - **\$53.00**
- 2024 Social Playing Membership - **\$37.00**
- 2024 Carnival Membership - **\$23.00**
- 2024 Non-Playing Membership - **\$0.00**

The following caps apply:

- 2024 Playing Membership - **\$112.00**
- 2024 NetSetGO! - **\$105.00**
- 2024 Social Playing Membership - **\$37.00**
- 2024 Non-Playing Membership - **\$0.00**

For the removal of doubt, the 10 Week Season membership product falls within the 2024 Playing Membership cap, as does the 2024 Carnival Membership.

Registrations for Season 2024 will open in NetballConnect on Friday 1 December 2023.

As has been the case in previous years, when a participant registers for any combination of the above four cap 'tiers', they will automatically move to the higher cost cap. Competition organisers, please note, when you are setting up competitions later in the year through NetballConnect, when NetSetGO! participants may be moving towards participating in netball activities that are not restricted to the NetSetGO! program and are not appropriate to be registering in NetSetGO! programs.

To make it very clear, the NetSetGO! membership product is not compatible with any other membership product for the participant to remain at the 2024 NetSetGO! cap. There are no short season options that are available for NetSetGO!, as there is a Netball Australia fee component attached to NetSetGO! program registrations.

For example, a participant that registers with a 2024 NetSetGO! (Pack Eligible) as part of the registration in January, February, etc. then is registered again in September, October, etc. in a 10 Week Season is going to have a charge included in the registration that is the difference between the 2024 NetSetGO! cap and the 2024 Playing Membership cap (\$7.00).

The following membership products are time sensitive:

- 2024 10 Week Season – 70 days
- 2024 Carnival Membership – 3 days

All other 2024 membership products referred to above run until the end of Netball Queensland's membership period, being Tuesday 31 December 2024, irrespective of when they were purchased, December 2023, December 2024 or anywhere in between.

The following membership products are available through application, as Terms and Conditions may be required to be agreed to by the association / club before the membership product is available:

- 2024 NetSetGO! (Pack Eligible)
- 2024 Social Playing Membership

People that are involved in the facilitation of netball and netball activities within your associations and clubs that do not participate as players need to be registered on NetballConnect, under the appropriate category (coach, umpire, volunteer, committee / life member). Registering in NetballConnect requires the person to agree to Netball Queensland's policies, as they become a member (Category Four) of Netball Queensland, but they are also required to agree to abide by your organisation's policies / terms and conditions. The other reason that people who perform roles in facilitating netball and netball activities is that it shows that they are registered in the event of an insurance claim arising that involves them. It cannot be stressed how important that this process is implemented within your associations and clubs.

One change that has been made to the 2024 Playing Membership is the change in age limits. The minimum age for this product is now two years of age (previously it was seven). Please note that children aged five and six now have the option of being registered under the following membership products, not just NetSetGO!:

- 2024 Playing Membership
- 2024 10 Week Season
- 2024 Carnival
