IMPORTANT INFORMATION

As referenced in the NQ Constitution:

- **Honorary Life Members** - Up to two Honorary Life Members shall be elected in any one calendar year (5.5 b).
- **Rights** - Honorary Life Members shall not in that capacity be entitled to vote at meetings of the Company (5.5 c)
- **Entitlements** – Honorary Life Members shall be entitled to receive notice of, attend and speak at General Meetings of the Company and to receive such other rights and privileges as the Company may from time to time determine.
- **Election of Honorary Life Members** – refer to clause 5.5 (e) of NQ Constitution for the complete process
